#### Content management and authoring

This core module comprises the actual Tridion Docs CCMS back end, such as the tools for content storage, authoring (Draft Space and Review Space) and import/export.

### GenAI service for Draft Companion

The Draft Space authoring tool comes with an optional module called Draft Companion, which provides GenAI capabilities to assist the author. Although Draft Companion itself can be part of an on-premises or cloud-based installation, the actual GenAI service always resides in the RWS cloud and cannot be hosted on-premises.

### **Tridion Docs Genius**

The optional Tridion Docs Genius portal is fully cloud based. Both the web application and the back-end AI services that it uses are hosted in the RWS cloud. However, Tridion Docs Genius can be connected to both on-premises and cloud-based instances of the Tridion Docs content management and authoring installation.

#### Headless content delivery APIs (DXD)

The optional Tridion Dynamic Experience Delivery (DXD) module provides programmatic (API) access to the content stored in Tridion Docs. It is always hosted in the RWS cloud but can be connected to both on-premises and cloud-based instances of the Tridion Docs content management and authoring installation.

### Custom solution development

Tridion Docs is a highly extensible and interoperable platform. To help developers customize your solution, we provide a virtual workspace connected to a development environment that runs the latest version of services.

### Business continuity and disaster recovery
